TO THE 21ST ANNUAL A. L. SLONAKER HALL OF FAME & 92ND ANNIVERSARY AWARDS BANQUET

When the local Delta Phi Fraternity affiliated with Kappa Sigma in 1915 as the Gamma-Rho Chapter, its members established a tradition of excellence and brotherhood which has been cherished and nurtured by each succeeding generation of members.

As of today, approximately 1,700 men have been initiated into the Brotherhood. There are now approximately 1,200 living Gamma-Rho alumni who, with few exceptions, were members of an active chapter that was the clear leader on the University of Arizona campus. Year after year, as individuals and as a group, the men of Gamma-Rho have distinguished themselves with high academic standards, excellence in athletics, and campus leadership.

The dimension of brotherhood has always been the chapter's greatest strength. Many close ties which began in the chapter have flourished for entire lifetimes. Large numbers of alumni are residents of the same communities, while others still sharing the bond live across the country from each other. The common interests of Gamma-Rho brothers have changed in many cases but the beginnings of friendship always go back to their association in the fraternity.

While this year marks our 92nd year on the Arizona campus, it also is the 21st Annual Hall of Fame Awards Banquet. Conceived as a way of honoring alumni for outstanding achievements, this award has become an integral part of the tradition at Gamma-Rho. Inductees are among a select group of alumni. Recognition is given to those who have excelled in their career, in their service to the community, and/or to the fraternity. In conjunction with the A. L. Slonaker Hall of Fame inductees Gamma-Rho also honors an alumnus as the Mike Cagalj Man of the Year and recognizes several other alumni and undergraduates for awards.

Bill Gladney '94 (Rho, Arizona State)

Brother Gladney was initiated at the Rho Chapter at Arizona State University on January 16, 1994. As an undergraduate, Bill held the office of grand scribe and served as the IFC pledge education chairman.

As an alumnus, Brother Gladney served as alumnus advisor for Rho Chapter from 1999 to 2003, while also serving as the alumnus advisor for Kappa-Gamma Chapter at Northern Arizona from 2000 to 2003. Brother Gladney has also served Kappa Sigma as district grand master (2003 - 2004), assistant DGM, and as a member of the Risk Management Committee which developed Kappa Sigma's revised My Brother's Keeper Program. Brother Gladney has received several awards for his service including Kappa Sigma Alumnus Advisor of the Year (2001), Arizona State University Advisor of the Year (2002), and Outstanding Assistant District Grand Master at the 2007 Grand Conclave in Miami, FL.

Brother Gladney currently holds the positions of alumnus advisor of Kappa-Gamma Chapter, grand scribe for the Greater Phoenix Alumni Chapter of which he is a founding member, and as a board member of the Rho Chapter House Corporation and the Rho Chapter Scholarship Foundation. Brother Gladney is also one of Jackson's Men (#1501).

Aside from his involvement with Kappa Sigma Fraternity, Bill has also been involved in several local community organizations including the Rio Salado Little League where he served as league president.

THOMAS W. KEATING

CIVIC LEADER AWARD

Dr. Randy Christensen '89

Brother Randy Christensen considers himself the luckiest person alive. He is blessed with a wonderful wife, Amy (also an M.D.), three children: Jane Marie, Reed Coleman, and Charlotte Lee, and he is also a successful doctor. Randy has used his skills and blessings to help those less fortunate in the community and in doing so, has honored the Gamma-Rho Chapter of Kappa Sigma.

Brother Christensen received his degree in 1990, then enrolled in Tufts School of Medicine, where he graduated in 1995 with his M.D. as well as an M.P.H. (master's of public health). He then embarked on his professional career, starting work with the Phoenix Children's Hospital in 1998 where he serves as a faculty physician today.

"I spend my time inside the hospital teaching medical students and residents. As part of an academic team we take care of some of the sickest children in the state."

His commitment to offer medical help to sick children does not end there. He is also the medical director of the Crews'N Healthmobile. "This is a mobile medical unit that takes care of homeless children and adolescents." Crews'N Healthmobile, established by Phoenix Children's Hospital and HomeBase Youth Services with the help of The Children's Health Fund, provides medical help to some 5,000 homeless children and teenagers in Arizona and served more than 2,000 teens last year for free.

The mobile unit is staffed with medical practitioners from Phoenix Children's Hospital and case managers from HomeBase Youth Services. Health services include examinations, immunizations, dispensing of medications, treatment for sexually transmitted illnesses and infections, various medical conditions, minor surgical procedures, health education, and counseling and referrals to specialists and sub-specialists at Phoenix Children's Hospital. Case managers coordinate referrals, complete AHCCCS applications, and

transport patients as needed.

Staff also screen, test, educate, and counsel youth on sexually transmitted infections, abstinence, HIV, Hepatitis A, B, and C, depression, anxiety, mood disorder, anger management, suicide risk, substance abuse, pregnancy, smoking cessation, nutrition, relationship and safety issues, and self care.

This year, for his efforts with the Crews'N Healthmobile, Brother Christensen was nominated for and selected as one of the CNN Heroes in the "Medical Marvel" category. He was one of six finalists, finishing second in the polling, thanks to the support from his Gamma-Rho brothers.

While Randy was honored by the nomination, he was more pleased with the exposure and support that the Crews'N Healthmobile received than any personal accolades.

Randy has also been involved as the medical director of Camp AZDA, one of the largest camps for children with diabetes in the U.S., and founded Informed Media, LLC, which is involved in the production of high quality educational medical skills videos for residency training programs and practicing physicians.

In the fall of 2005, after the Gulf Coast was hit by Hurricane Katrina, Brother Christensen organized and supervised a medical relief team that deployed to towns throughout northeast Louisiana. Their team was the first with physicians to see patients in devastated small towns such as Angie, LA. The team set up multiple medical clinics and aided with supply centers.

Malcolm Mathes '67

Brother Malcolm Mathes '67 enrolled in the University of Arizona in the fall of 1966 and pledged Kappa Sigma. He was involved as an undergraduate, serving as grand master from 1969 - 1970 and received the "Most Inspirational Active" award in 1970. He was also involved on campus, serving in the Fraternity Presidents Club of the U of A.

Malcolm graduated with a bachelor of science in business administration in 1970 and used the lessons learned as grand master to begin his successful career in the banking industry. His career track includes a tenure as president and CEO at the First National Bank of McMinnville between 1985 - 1987 where he revitalized the 104 year-old bank's presence in the market and was awarded "Boss of the Year" honors in 1985 by the McMinnville Chapter of Credit Women International.

Brother Mathes spent six years as the senior vice president and manager of the Consumer Loan Division with Key Bank of Oregon where he directed all lending activities for an 80 branch system with a staff of 100. He then spent a year as senior vice president and marketing director for Key Bank of Oregon where he directed and coordinated marketing, public relations, and corporate giving for a \$2 billion, 80+ branch bank with over 500 employees.

He then left Oregon for Ohio, where Malcolm spent three years working with Key Auto Finance as a senior vice president and regional manager, where he assisted in development and implemented national strategy for a top 10 auto finance lender. His leadership resulted in a 73% improvement in efficiency.

He returned to Oregon and is currently the senior vice president and area executive for the Sterling Savings Bank where he is responsible for the retail sales for the largest district, consisting of business banking, private banking, and 51 retail branches.

Brother Mathes is very involved in the local community as a member of the Lake Oswego Rotary Club, the Lake Oswego Arts Foundation, and the Lake

Oswego Heritage Council. He is also a board member and past president of the Lakewood Center for the Arts.

He and his wife, Linda, have two children, Robin (28) and Darrell (25).

“Looking back on my fraternity days, I now realize they were more than just having good times and establishing lifetime affiliations. It was a once-in-a-lifetime opportunity for a group of ‘brothers’ to encourage one another and to bring the best out in each of us. The fraternity gave me my first opportunity to learn about leadership and the appreciation for community service.”

Mark Casey '82

Mark Casey was initiated into the Gamma-Rho Chapter in 1982. “Case” was very involved with the chapter as an undergrad, serving as the social chair, the little sisters chair, the grand treasurer, and the grand procurator.

He received a job in outside sales with Curbell, Inc. right after graduating from the University of Arizona in 1983 with a B.S. in business administration. It wasn't long before he was the national sales manager, doing \$22 - \$24 million in sales. From 1992 through 2001 he held the post of general manager where he was responsible for \$24 - \$100 million.

In 2002 he left and formed Professional Plastics where he serves as general manager and partner. The business has continually grown, having done about \$10 million in sales just this year.

Case has also served on the board of the International Association of Plastics Distribution from 1995 - 2002, including serving as president between 2000 and 2002. He has also served as advisor and counsel for G.E. Silicons, Bear, and Eng-Plastics.

Mark and his wife Sandy have three children: Eddie (16), Brian (15), and Paige (12).

Gary Foster '62

Gary says that after he decided to pledge Kappa Sigma he didn't have to make the decision to move from his dorm into the house because the brothers made that decision for him. They came over to the dorm and moved his stuff into the chapter house. This begins one of the many stories about his life and his friends at Kappa Sigma that he tells so well. He has a million of them.

While he was an undergraduate at Gamma-Rho he was grand master and held many other leadership positions through the years. The many good friends that he made at Gamma-Rho could be listed, but inevitably, someone would be left out and their feelings hurt which would make Gary also feel badly. Brother Foster continues to make new friends but he never discards old friends.

Gray's brother Rod and his sister Charlotte are all Arizona graduates. Rod followed in Gary's footsteps and was initiated into Gamma-Rho in 1969. Charlotte is an Alpha Phi.

Gary and his wife Glenda have three children: Brian, Stacy, and Joanna. All, like their parents, are graduates from the U of A.

After receiving a degree in agriculture, Gary and Glenda returned to Brawley, CA. His father, Howard, could hardly wait for him to go work and help him with the family business. Gary, Rod, and their father worked hard at building many successful enterprises around the cattle business.

To this day, Brothers Gary and Rod Foster are carrying on quite successfully in the business, in a manner that would make Howard and Blanch Foster proud of them.

In Brawley, Gary is proud of his membership in the Elks, Stockman's Club, and many other organizations. Brother Foster has served many years on the board of the Stockman's Club, including holding the position of president.

In 2005, Gary was inducted into the prestigious Imperial County Football Hall of Fame, a testimony to his athletic ability.

Gary's love for Kappa Sigma was once again shown when he and three other Gamma-Rho brothers, Mike Cagalj '58, Don Harris '59, and Tom Keating '62 asked him to join them in purchasing an apartment complex on Park Avenue in Tucson to give the brothers of Gamma-Rho a home. This complex, lovingly referred to by the brothers who lived there as El Cap (short for El Capitan) held the chapter together until we moved into the present, beautiful chapter house on First Street.

Gary, a 1989 inductee into the Gamma-Rho Hall of Fame, has been a significant contributor to the new house both as a donor and as someone who has helped us recently when it came to refinancing the house. Two years ago he was asked to help guarantee the Gamma-Rho house loan. Gary, along with the usual suspects, Don Harris '59 and Tom Keating '62, and now Carl Russell '59, have all stepped up and made a tremendous commitment.

While he was an undergraduate Kappa Sigma he built himself some memories that he will never forget. If you wish to test this, just ask him, and one of the greatest story tellers you have ever heard will share them with you. Maybe this year at Homecoming he can build himself some new memories.




